WHEREAS, Russ Gibbons has submitted an application for a new Special Amusement Permit for Kampgrounds of America dba Terramor Outdoor Resort located at 1453 State Hwy 102, pursuant to Chapter 14-3 of the Bar Harbor Code; and

WHEREAS, the application is for a Class 3ad, three or more musicians with mechanical amplification and dancing; and

WHEREAS, this application is distinct from the one considered and denied by the Town Council on October 21, 2025; the current application is for a class of permit that only allows indoor amplified music, proposed for the lodge building at the resort; and

WHEREAS, the applicant noted the above instance of a Special Amusement Permit having been denied, and certified that neither the applicant nor any partners or corporate officers of the business have ever been convicted of a felony; and

WHEREAS, the application fee was paid; and

WHEREAS, notice was given of the February 2, 2026 public hearing through a notice on the Municipal Building Bulletin Board posted on January 23, 2026, notice on the town's website posted January 23, 2026, a public notice in the January 29, 2026 edition of the Mount Desert Islander newspaper, and a notice to abutting property owners within 300 feet mailed January 28, 2026; and

WHEREAS, said public hearing was held on February 2, 2026;

NOW THEREFORE, BE IT ORDERED, that the Bar Harbor Town Council hereby approves a Class 3ad Special Amusement Permit for Terramor Outdoor Resort for the license year of the applicant's existing liquor license.



NOTICE OF PUBLIC HEARING

New Special Amusement Permit

The Bar Harbor Town Council will hold a public hearing **Tuesday, February 3, 2026 at 6:30 pm** in the Council Chambers, Municipal Building, 93 Cottage Street, to consider an application for a new Class 3ad Special Amusement Permit, three or more musicians with mechanical amplification and dancing as submitted by:

Russ Gibbons
Terramor Outdoor Resort
1453 State Hwy 102

This is a **new application**, following Town Council denial in October 2025 of an application from this business for a different class of Special Amusement Permit, one that included outdoor amplification. **This application is for indoor music and dancing, to be limited to the Lodge building at the Terramor resort.** The Town Council also plans to consider revisions to the controlling ordinance in the coming months; if revisions are adopted, all permit holders would be required to reapply under any new requirements.

As an abutting property owner within 300 feet of the boundary of the above property, you are hereby notified that this hearing will take place. You may wish to attend the hearing where you will be given an opportunity to make comments or ask questions.
