 No Shall an ordinance, dated November 19, 2021, and entitled "An amendment to remove the two-thirds majority vote requirement to amend the Land Use Ordinance;" be enacted?

Recommendations:

*The seven-member Planning Board recommends adoption by a vote of 4 to 2 with one abstention.
The 15-member Warrant Committee recommends adoption by a vote of 14 to 1.*

- Yes **Article 3 - CITIZEN PETITION FOR LAND USE ORDINANCE AMENDMENT: Daily Limits on Cruise Ship Disembarkations Ordinance**
 No Shall an ordinance dated July 19, 2022 and entitled "An amendment to the Town of Bar Harbor Code to Impose Daily Limits on Cruise Ship Disembarkations," be enacted?

Recommendations:

*The seven-member Planning Board recommends rejection by a vote of 6 to 0 with one abstention.
The 15-member Warrant Committee recommends rejection by a vote of 9 to 6.*

- Yes **Article 4 - CITIZENS' PETITION LAND USE ORDINANCE AMENDMENT - Marijuana Stores Ordinance**
 No Shall an ordinance dated August 16, 2022 and entitled "An amendment to allow Retail Marijuana Stores in the Downtown Village I, Downtown Village II, Bar Harbor Gateway, Downtown Village Transitional, and Shoreland Development III districts," be enacted?

Recommendations:

*The seven-member Planning Board recommends rejection by a vote of 5 to 1 with one abstention.
The 15-member Warrant Committee recommends adoption by a vote of 9 to 6.*

- Yes **Article 5 - CITIZENS' PETITION FOR ADULT USE MARIJUANA STORE LICENSING ORDINANCE**
 No Shall an ordinance dated August 16, 2022 and entitled "an Adult Use Marijuana Store Licensing Ordinance, allowing for the licensing of retail marijuana stores in zoning districts in which retail is an allowed use," be enacted?

Recommendations:

*The seven-member Town Council recommends rejection by a vote of 5 to 2.
The 15-member Warrant Committee recommends adoption by a vote of 9 to 6.*

- Yes **Article 6 - LAND USE ORDINANCE AMENDMENT - Appendix A - Historic Properties**
 No Shall an ordinance, dated August 11, 2022, and entitled "An Amendment to Appendix A – Historic Properties in Design Review Overlay District" be enacted?

Recommendations:

*The seven-member Planning Board recommends adoption by a vote of 6 to 0 with one abstention.
The 15-member Warrant Committee recommends adoption by a vote of 15 to 0.*
